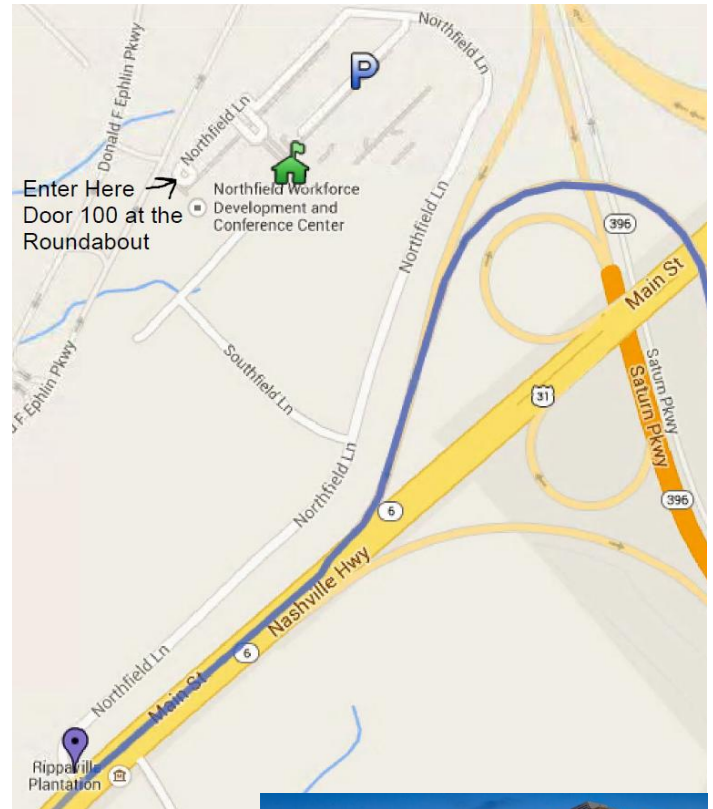
5000 Northfield Lane Spring Hill, TN 37174

From I-65 (north or south):

- Take Exit 53 Saturn Parkway
- Go approximately 4 miles (exit to US 31 south toward Columbia)
- Immediately once on US 31 South turn right into the Northfield entrance (5000 Northfield Lane), this will be across the road from Rippavilla Plantation next to the large sign with electronic display
- Follow the road around to the Northfield building then proceed all the way around to Door 100 underneath the awning at the roundabout. Park and enter on the East side of the building

From South:

- Take US-31 North toward Spring Hill
- Go approximately 1.5 miles north of Spring Hill High School
- Turn left into the Northfield entrance (5000 Northfield Lane), this will be across the road from Rippavilla Plantation next to the large sign with electronic display
- Follow the road to the Northfield building then proceed all the way around to Door 100 underneath the awning at the roundabout. Park and enter on the East side of the building
